## Website Privacy Policy

I. MILLERCREEKMUSIC.COM (the "Company") is in the business of providing information and materials from the musical act Miller Creek. As such, the Company respects your individual privacy. This Privacy Statement protects your privacy by:

A. Informing you about:

- i. the type of personal information the Company collects about you through this Web site
- ii. how that information is collected
- iii. the general purposes for which that information is collected
- iv. what disclosures of information will be made
- v. how, and to what extent, you can limit those disclosures

B. Assuring you that:

- i. reasonable precautions are taken to protect your personal information from loss, misuse, unauthorized access, disclosures, alteration or destruction;
- ii. reasonable policies and procedures are in place to insure that your personal information is kept only for the purposes for which it was gathered;

### III. Collecting Personal Information

Some information about your IP address, Web browser, and computer system are automatically transmitted to our Web servers as an integral part of the operation of the Internet. Thus, we reserve the right to automatically collect and/or track

### IV. Cookie Disclosure Information
